Dear Sir,

RE: DEFAMATORY STATEMENTS

- 1. I write to you regarding the incident that occurred in front of your house and my house on 10 January 2022.
- 2. It has come to my attention that during the incident you posted defamatory statements regarding me on the KleinBron Als Whatsapp group.
- 3. In the defamatory statements you:
 - 3.1. claimed that you had just caught me filming your child in a towel; as though I had been hiding and filming your child with perverted intentions, and
 - 3.2. implied that Charl du Toit, the owner of SJC Security, arrived to assist you to sort it out, when my wife had been the one who called security.
- 4. Your comments were made with the intention to slander and defame me. It is clear that by insinuating that I am a paedophile, you intended to do as much damage as possible to my reputation.
- 5. The damage to my reputation is evident in that many members on the KleinBron Als Whatsapp group have blocked my wife, who is a member of the KleinBron Als Whatsapp group, and refuse to have anything to do with her.

- 6. There are prominent members of the community, who are members of the KleinBron Als Whatsapp group, including Wimpie and Le Lue Van Der Sandt, the owners of Bok Radio, and LeLue even responded to your comment.
- 7. Charl du Toit, the owner of SJC Security, is a member of the group.
- 8. Klein Bron Estate's manager, the trustees, and the owner of SJC Security have become involved in the matter and I have had to suffer the degradation of having to explain to them that I am not a paedophile.
- 9. Many residents in the estate give me and my family dirty looks when we are outside our house.
- 10. There is no chance of my family being able to have a normal neighbourly relationship with our neighbours again.
- 11. I will not be able to escape from the stigma of having been labelled a paedophile whilst I live in Klein Bron Estate. Nobody wants to associate with someone when there is even just the mere suggestion of paedophilia, even if it is untrue.
- 12. I live in constant fear that another group of parents will come and attack me at my house.
- 13. Our children will not be able to play normally outside with the other neighbourhood children when they are older because of the stigma.
- 14. Due to your comments, I have suffered reputational damages in the amount of R200,000.00.
- 15. I demand the following:
 - 15.1. That payment of the R200,000.00 be made into my bank account, the details of which appear herein below, within 7 (seven) days of receipt hereof, failing which I will issue summons against you.
