In terms of sections 3(3) and 15(a) of the Protection from Harassment Act, 2011,(name and surname), who is a *clerk-of-court/*sheriff/ *peace officer is hereby directed to serve the interim protection order, a copy of the application for a protection order and the record of evidence noted on the respondent in accordance with regulation 28 of the Protection from Harassment Regulations, 2013.

Her name appears on the Stellenbosch University anaesthesiology staff web page, but there is no photo.

The person in the photo claims to be Dr Marianne Johnson, and that she is employed as an anaesthetist at Tygerberg Hospital.

Could you please confirm if the person in the photo is Dr Marianne Johnson, and if she is your staff member.

There is someone registered with HPCSA with the name Marianne Johnson, but there are no photos on their website. There may be someone with that name who really is an anaesthetist, but I don't think it is the person in the photo. The person in the photo is often seen wearing hospital theater clothes in public, but she has no medical knowledge. If you see her, please question her thoroughly.

We suspect the person in the photo has either bribed or manipulated someone at the Stellenbosch IT department to upload her photo on your website.

If the person in the photo is not an anaesthetist who works at Tygerberg and Stellenbosch, please contact the police as soon as possible. Her address is 19 Kleinbron Avenue, Kleinbron Estate, Cape Town, 7560.
