

# Annexure E – Incidents of Harassment by Bongi to Mrs Sonet Fitchat

## **SEPTEMBER 2021: GRASS**

1. Bongi kept walking over our newly planted grass, despite the “Keep off the Grass” signs, and despite me asking her not to.

## **8 OCTOBER 2021: NOISE AT NIGHT**

2. The Franken children and their friends, including Bongi, were playing outside Mrs Franken’s house and were shouting and wakin gup our baby, so I asked Mrs Franken to ask them to be quiet. She did.

## **9-11 OCTOBER 2021: NOISE AT NIGHT**

4. The Franken children and their friends, including Bongi, made a noise outside our house in the evenings, keeping waking up our children..

## **±13 OCTOBER 2021: SCREAMING BY DAM**

5. A group of girls including Bongi, were standing by the dam across from our house, and facing our house, started screaming. They were shouting so loudly that I could hear them on the other side of the house, and they were again waking up our baby. When I told them to be quiet, Bongi stepped forward and in a disrespectful tone of voice said, “Meow”. I asked if I had to call security.

## **±14 OCTOBER 2021: PLAKKIES**

6. When me and my husband went for a walk, Bongi and Mia Cloete went to stand in the road in front of our house and they repeatedly kicked off their plakkies onto our grass, and then ran over our grass to go pick them up.

## **13-18 OCTOBER 2021: NOISE AT NIGHT**

7. The Franken children and their friends, including Bongi, made more and more noise outside our bedroom windows, especially 19:55-20:00 nearly every night. Our children go to bed at about 20:00.

## **±15 OCTOBER 2021: BEES**

8. Mrs Franken came to our house and said there were bees in the wall between our houses. Mrs Franken’s daughter came with her. Bongi was in the street with a friend, and tried to follow Mrs Franken’s daughter into our house, but I closed the door before she could come in.

## **20 OCTOBER 2021: PLAKKIE**

9. A pink plakkie was lying on the grass between our and the Frankens’ houses.
10. That evening, Alaina, Bongi and Bongi’s brother were bouncing a ball outside our bedroom window. Our baby had just gone to bed, so I asked them if they could go play by the dam.

## **END OF OCTOBER 2021: NOISE**

11. For many days after that, Bongi and Mia would stand in front of the Frankens' house, near our house, give a short loud scream, and then quickly run away. They did this in the afternoons, evenings, and at night.

#### **END OF OCTOBER 2021 – NOVEMBER 2021: RAMP NOISE**

12. Also, whenever I went to the kitchen and I appeared at my kitchen window, if a certain group of children, who always included Bongi, were playing by the dam, they would stop what they were doing, walk over to our ramp, and start playing and making a noise on the ramp.

13. I closed my kitchen blinds for most of December 2021 and the children stopped. I opened them again in January 2022, and Bongi and her friends started again.

#### **25 DECEMBER 2021: NOTE LEFT AT DOOR**

14. As soon as my husband went to bath our toddler, there was a loud knock on the door. I didn't answer, but later discovered a note was left at our door.

#### **30 DECEMBER 2021: BONGI INCIDENT**

16. I saw a coloured girl and white boy, whom I had never seen before, playing right in front of our bottom ramp and it looked like they were trying to throw their ball over our wall, to where our Rottweiler was. The coloured girl called, "Bongi", waved to where Bongi was on the other side of the dam, beckoned to her to come, and gave her a thumbs up.

17. I told my husband what I saw, and my husband went out to speak to Bongi, taking the dog with him.

18. Through the kitchen window I saw that as soon as the coloured girl and white boy saw my husband, they immediately started following him. The coloured girl again called "Bongi", waved to her, and pointed aggressively to my husband.

19. After my husband spoke to Bongi, he came back.

20. Shortly after that, I looked out the front door and I saw Bongi's mother and a black man walking aggressively to our house.

21. I was scared, so I called security.

#### **1-2 JANUARY 2022: POST BONGI INCIDENT**

22. Bongi played outside with some friends on the other side of the dam, near her own house.

#### **3 JANUARY 2022: POST BONGI INCIDENT**

23. Bongi played on a jungle gym, on our side of the dam and near our house, with a group of children.

#### **4-6 JANUARY 2022: POST BONGI INCIDENT**

24. Bongi played outside on our side of the dam, near our house. She and her friends would pretend to hide behind a tree, then they quickly ran behind some other trees across from our house, looking at our house, and pretending to be scared of us.
